Citizen Comments:

John Evans - Monticello Citizen

John explained that it would be nice to have the information presented at commission meeting before so that it could be reviewed.

Kim Henderson - Monticello Citizen

Kim asked the commission for transparency as to who has participated in writing the resolutions presented at the commission and asked where she could find the information.

Suzette Morris - White Mesa Citizen

Suzette expressed her thoughts about respect for all county citizens. She asked that translation for translation of comments made in another language so that everyone could understand what is being said. She also explained there should not be discrimination???? (10:00)??

Vaughn Hadenfeldt - Bluff Citizen and Chairman of Friends of Cedar Mesa

Vaughn explained that Friends of Cedar Mesa is not against energy development but shared that it should be done responsibly and in appropriate places. He also expressed concern of pursuing the sale of leases while there is litigation going on.

Brant Murray - Bluff Town Council

Brant expressed the need for transparency with Bluff Town over the proposed solar grid and asked that the county consider communicating with Bluff. He also stated that he's concerned about the solar project.

Joe B. Lyman - Blanding Citizen

Joe expressed his opposition with regards to the resolution covering policy and position of the county as well as the resolutions covering the Bears Ears.

Cheryl Bowers - Blanding Citizen

Cheryl spoke about domestic violence and mentioned a training that took place within the county. She also spoke about management of the Bears Ears National Monument.

David Carpenter - SJC Recorder

David presented, for approval, a summary of his procurement requests that were discussed at the February 19, 2019 Commission Work Meeting. A motion to approve the procurement requests was made by Commissioner Adams and 2nd by Commissioner Grayeyes. Voting was unanimous.

Scott Burton - SJC Deputy Assessor

Scott presented the amended Tate subdivision, north of Blanding, for signature. He explained that the amended is for a boundary adjustment to the subdivision. A motion to approve the amended subdivision was made by Commissioner Adams and 2nd by Commissioner Grayeyes. Voting was unanimous.

Walter Bird - SJC Personnel

Walter presented new hires requests for Deputy County Attorney and a Blanding Library Assistant. Walter explained that 3 individuals were interviewed for the deputy attorney position and that Alex Goble was the interviewing committee's first choice. A motion to approve the hire was made by Commissioner Adams. Commissioner Grayeyes 2nd the motion and asked what the caseload would be. After Attorney Kendall Laws answered the question the motion passed. Voting was unanimous.

Walter also requested that the Blanding Library Assistant position be offered to Kalynne Pincock with Julia Shumway as alternate. He mentioned that 5 individuals were interviewed. A motion to approve the offer was made by Commissioner Grayeyes and 2nd by Commissioner Adams. Voting was unanimous.

Tammy Gallegos - SJC Administration

Tammy presented closing documents for the mental health day treatment to be signed. A motion to sign the documents was made by Commissioner Grayeyes and 2nd by Commissioner Adams. Voting was unanimous.

Kenneth Maryboy - SJC Commissioner

Commissioner Maryboy directed that the resolutions listed below be read and considered for approval. After the resolutions were read Commissioner Maryboy passed the chair to Commissioner Adams.

1 - RESOLUTION DIRECTING THAT THE COUNTY ADMINISTRATOR COMMENCE LIVE VIDEO STREAMING AND LIVE AUDIO STREAMING OF COUNTY COMMISSION MEETINGS AND WORK SESSIONS FOR ONLINE VIEWING AND PARTICIPATION

A motion to approve the resolution was made by Commissioner Maryboy and 2nd by Commissioner Grayeyes. Commissioners voting in favor of the resolution were Commissioners Maryboy and Grayeyes. Commissioner voting against the resolutions was Commissioner Adams.

2 - RESOLUTION SUPPORTING H.R. 871, THE BEARS EARS EXPANSION AND RESPECT FOR SOVEREIGNTY ACT, WHICH HAS BEEN INTRODUCED IN THE UNITED STATES HOUSE OF REPRESENTATIVES, 116TH CONGRESS TO EXPAND THE BOUNDARIES OF THE BEARS EARS NATIONAL MONUMENT, ENSURE PROMPT ENGAGEMENT WITH THE BEARS EARS COMMISSION AND PROMPT IMPLEMENTATION OF PRESIDENTIAL PROCLAMATION 9558, DATED DECEMBER 28, 2016, ESTABLISHING THE BEARS EARS NATIONAL MONUMENT.

A motion to approve the resolution was made by Commissioner Maryboy and 2nd by Commissioner Grayeyes. Commissioners voting in favor of the resolution were Commissioners Maryboy and Grayeyes. Commissioner voting against the resolutions was Commissioner Adams.

3 - RESOLUTION DIRECTING THAT NO SAN JUAN COUNTY OFFICIAL OR EMPLOYEE MAY REPRESENT THAT A POLICY OR POSITION IS A POLICY OR POSITION OF THE COUNTY UNLESS THE SAN JUAN COUNTY COMMISSION HAS FIRST REVIEWED AND APPROVED THAT POSITION IN A FORMAL RESOLUTION OF THE COMMISSION.

A motion to approve the resolution was made by Commissioner Grayeyes and 2nd by Commissioner Maryboy. Commissioner Grayeyes wondered if the resolution might defeat the purpose as county representatives in being able to take a position. Commissioner Adams agreed with Commissioner Grayeyes as did Commissioner Maryboy. After a brief discussion, Commissioner Grayeyes amended his motion to oppose the resolution. Commissioner Maryboy 2nd the amended motion. Voting was unanimous.

4 - RESOLUTION DIRECTING THAT THE COUNTY ADMINISTRATOR COMPILE AN ORGANIZATIONAL CHART OF ALL SAN JUAN COUNTY OFFICERS AND EMPLOYEES.

A motion to approve the resolution was made by Commissioner Grayeyes and 2nd by Commissioner Maryboys. Commissioners voting in favor of the resolution were Commissioners Maryboy and Grayeyes. Commissioner voting against the resolutions was Commissioner Adams.

5 - RESOLUTION DIRECTING THAT THE COUNTY ADMINISTRATOR COMPILE ALL PROCEDURES USED BY THE SAN JUAN COUNTY COMMISSION IN THE REVIEW AND CONSIDERATION OF OFFICIAL ACTIONS TAKEN BY THE COMMISSION.

After a motion to approve the resolution was made by Commissioner Marboy, Commissioner Grayeyes requested that the resolution be tabled.

6 - RESOLUTION OPPOSING UTAH H.B. 93 AMENDING UTAH CODE 17-3-3 COUNTY FORMATION TO DELETE THE STATUTORY REQUIREMENT OF A MAJORITY VOTE OF BOTH PORTIONS OF A COUNTY N THE EVENT OF A PROPOSED SPLITTING OF THE COUNTY.

A motion to approve the resolution was made by Commissioner Maryboy. The motion died due to lack of a 2nd to the motion. Commissioner Adams passed the chair back to Commissioner Maryboy. Commissioner Adams made a motion to oppose the resolution because H.B. 93 no longer affects San Juan County. Commissioner Grayeyes 2nd the motion. Voting was unanimous.

7 - RESOLUTION DIRECTING THAT THE COUNTY ATTORNEY SHALL PROVIDE WRITTEN LEGAL MEMORANDA CONTAINING A COMPLETE LEGAL ANALYSIS OF ALL PROPOSED COMMISSION RESOLUTIONS SUBMITTED FOR REVIEW IN ADVANCE OF AN COMMISSION MEETING WHERE THOSE RESOLUTIONS WILL BE CONSIDERED OR ACTED UPON.

Commissioner Maryboy passed the chair back to Commissioner Adams. A motion to approve the resolution was made by Commissioner Grayeyes and was 2nd by Commissioner Maryboy. Commissioners voting in favor of the resolution were Commissioners Marboy and Grayeyes. Commissioner Adams voted against the resolution.

Commissioner Adams passed the chair back to Commissioner Marboy.
