PUBLIC NOTICE (AMENDED)

I hereby inform you that the candidates are to be elected for the following offices at the upcoming General Election in San Juan County, Utah, to be held Tuesday, November 8, 2022. Any resident intending to become a candidate for any elective office to be filed at the next ensuing November General Election shall file with the County Clerk for all precinct, county and school board offices solely within a county, for all other State and Federal offices individuals shall file with Lieutenant Governor or County Clerk as per Utah code.

The Declaration of Candidacy filing period for Qualified Political Party Candidates and Local School Board of Education Candidates begins Monday, February 28, 2022 at 8:00 a.m. and ends Friday, March 4, 2022 at 5:00 p.m.

The Declaration of Candidacy filing periods for Justices and Judges of Court begins Friday, July 1, 2022 at 8:00 a.m. and ends Friday, July 15, 2022 at 5:00 p.m.

The Declaration of Intent to Gather Signatures for qualified political party candidates began on Monday, January 3, 2022 at 8:00 a.m. and ends Friday, March 4, 2022 at 5:00 p.m.

Qualified political party candidates must submit nomination petition signatures no later than 14 days before the day of which the qualified political party holds its convention to select candidates for the elective office.

FEDERAL

U.S. Senate – Senator will be elected for a six (6) year term U.S House of Representative - 3rd District for a two (2) year term

STATE

State Treasurer will be elected for a four (4) year term

State House of Representatives - One (1) member for a two (2) year term from each of the seventy five (75) districts. (San Juan County is District 73.)

JUDICIAL

Justice Court – There will be a retention election for one (1) Judge in the Seventh Judicial District (7th), provided that the incumbent who's term is expiring files during the filing period.
